

## Transportation notification submissions

Note: This quick reference guide applies to centre-based services only. Family day care services are not required to submit transportation notifications to their regulatory authority.

### Introduction

Amended regulations for regular transportation to and from centre-based services came into effect 1st March 2023 and require approved providers to notify their regulatory authority under certain circumstances:

- Regulation 175(2)(f): A centre-based service starts providing, or arranging for, regular transportation of children for the first time.
- Regulation 175(2)(g): A centre-based service stops providing, or arranging for, regular transportation of children.
- Regulation 24(ha): An application for a centre-based service approval must include a description of any proposed regular transportation of children by or arranged by the service.

These changes assist your state or territory regulatory authority to further ensure the safety and wellbeing of children during regular transportation.

Further information on these amended regulations are available on the next slide.

The NQA ITS has been updated accordingly, as follows:

- A. The SA01/02 application form for a centre-based service approval requires indication of whether regular transportation will be provided or arranged. If it will be, the transportation is considered to be regular transportation, and a description of its provision or arrangement must be given. (See <a href="mailto:page 3">page 3</a>)
- 3. The SA12 notification form for notifying changes in services allows for notification of a change in regular transportation. If your centre-based service starts or stops providing or arranging for regular transportation of children, you may use this form for notification (See <a href="page 4">page 4</a>). Other changes to regular transportation do not need to be notified.
- Change of service regular transportation details can also be notified by accessing the service record through the Quick Edit function. (See <a href="page">page</a>
  5).

Note: You may use option B or C above to notify your regulatory authority of a change. They will both achieve the same outcome.

## The amended regulations on regular transportation



#### What is regular transportation in relation to an education and care service?

This is defined as the transportation by the service or arranged by the service (other than as part of an excursion) of a child being educated and cared for by the service, where the circumstances relevant to a risk assessment are substantially the same for each occasion on which the child is transported. (National Regulation 4).

Information on transportation <u>not</u> forming part of an education and care service is detailed in an <u>information sheet</u>. Some examples include:

- private transport provided by families and carers (i.e. carers not engaged by nor registered with an education and care service)
- transport provided and/or arranged by an entity other than the education and care approved provider, for example a school bus, and the children are not under the care of the approved provider
- transport where the education and care approved provider is providing the transport service in a capacity other than as the education and care approved provider for example a government department that provides an education and care service, provides school education, and provides a school bus to school students, on which the children who attend the education and care service also travel for practical reasons (such as in a remote or rural location)
- when a disability service picks up children and transports them to school or to an activity.

Regular transportation may look different for each service, so approved providers should consider what regular transportation is arranged or provided for each of their services to ensure the National Law and National Regulations are always complied with.

#### Elaboration on the regulations that require notification of regular transportation

The amended regulations apply only to centre-based services. It is mandatory to notify the regulatory authority that your service provides or arranges regular transportation, facilitated through the <u>NQA IT System</u>. The circumstances under which an approved provider must notify the regulatory authority are:

- in a service approval application, or if the service is already approved: within seven (7) days of regular transportation being provided or arranged by the service. (Regulations 24(ha) and 175(2)(f))
- when the service starts or stops providing or arranging regular transportation: the approved provider must notify the regulatory authority within seven (7) days if regular transportation provided by or arranged by the service ceases (Regulation 175(2)(g)).

Notifications are not required for one-off excursions or other forms of transport.

#### What type of information is expected to be included in the description of the regular transportation?

The information to be provided in the notification is not legislated, however the approved provider must ensure the regulatory authority is aware of regular transportation occurring or if the regular transportation is no longer provided.
